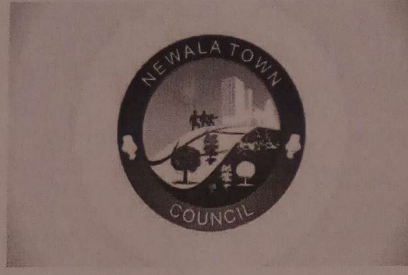

### CONSTRUCTION OF CHITANDI WATER SUPPLY PROJECT AT NEWALA TC

The Government of Tanzania has set aside funds for construction and rehabilitation of the water supply infrastructure during the financial year 2017-2018. It is intended that part of the proceeds of the funds will be used to cover eligible payment under the contract for construction of Chitandi water supply project in Newala Town Council. The Newala Town Council now invites sealed bids from eligible contractors registered in (**Class V and above**) for construction of Chitandi water supply project in Newala Town Council. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2013 - Government Notice No. 446 and are open to National Bidders only as defined in the Regulations unless otherwise stated in the Bid Data Sheet.
